The dissertation examines the role of the corpse in the historical narration of the battle of al-Qaşr al-Kabīr/Wādī al-Makhāzin (4 August 1578). Within a Western Mediterranean context, it contends that at the heart of the telling of the battle is a renegotiation of the epistemological foundation of how history is written, and that the renegotiation takes place on and through the corpses of those fallen at the battle. It identifies the human body as a connecting thread that weaves together key moments of witnessing, testimony, and reading in historiographical narrative. It shows that through images of corpses, the empathetic reader is drawn into bearing textual witness to the events being told and recruited as an ally to the narrator's cause.
