

## ITINERARY

### Day 1: Saturday Jun 5 2027: Departure from the US – Overnight flight.

Your journey to the heart of medieval Paris begins! Board your overnight flight to the City of Light, where centuries of history await. Settle into your seat, enjoy in-flight entertainment, and perhaps dive into a book or documentary on medieval France to set the mood. As you soar across the Atlantic, anticipate the architectural wonders, illuminated manuscripts, and Gothic masterpieces that will soon come to life before your eyes.

### Day 2: Sunday Jun 6 2027: Welcome to France.

Step off your international flight and into a land where every stone whispers history. Upon arrival at Paris Charles de Gaulle Airport, you'll be greeted by your local guide and private driver, ready to whisk you into the heart of France. Depending on your flight's arrival time, you may journey first to Senlis, a beautifully preserved medieval treasure once favored by the early Capetian kings. With its majestic cathedral, ancient ramparts, and winding cobblestone lanes, Senlis feels like a scene from a period film—indeed, it has starred in The Man in the Iron Mask and The Messenger: The Story of Joan of Arc. Meander through its picturesque streets, where half-timbered houses and flower-filled façades evoke centuries of charm. If time is limited, proceed directly to Paris for a panoramic city drive, offering a first glimpse of its splendor. From the Arc de Triomphe, Napoleon's monument to victory, to the glittering Champs-Élysées and elegant Place de la Concorde, the City of Light unfolds before you in timeless grandeur. Upon arrival at your centrally located hotel, take a moment to refresh and settle in. This evening, gather with fellow travelers for a Welcome Dinner. Overnight in Paris. (D)

### Day 3: Monday Jun 7 2027: Guided walking tour of Notre Dame – Sainte-Chapelle – The Conciergerie.

Wake up in the City of Light and prepare to step back into the age of kings, saints, and revolutionaries. After breakfast at your hotel, begin your day with an expertly guided walking tour through Île de la Cité, the historic island where Paris was born and where the echoes of medieval grandeur still resonate through cobbled lanes and timeless façades. Your first stop is the iconic Notre-Dame de Paris, the cathedral's soaring towers and sculpted façade still captivate with their Gothic majesty. Your guide brings to life the dramatic history behind this world-renowned structure—from its medieval builders to the modern architects working to restore it after the 2019 fire. Next, step inside the Sainte-Chapelle, the dazzling royal chapel commissioned by Saint Louis in the 13th century to house sacred relics. Bask in the glow of its towering stained-glass windows, where radiant panels depict biblical stories in breathtaking color. This intimate gem is more than a chapel—it's a spiritual and architectural masterpiece. After lunch at your leisure, continue for a private guided walking tour of the nearby Conciergerie and the Palais de la Cité—an extraordinary deep dive into medieval Paris and its transformation through the centuries. Originally the royal residence of the Capetian kings, the Palais de la Cité evolved into a judicial center and prison, with surviving structures such as the vast Salle des Gens d'Armes, the Salle des Gardes, and the kitchens built under John the Good. Walk through these solemn, vaulted halls where Gothic architecture meets royal ambition, and discover how justice, power, and faith intertwined on this very island. Stand in the cell once occupied by Marie-Antoinette, now memorialized by a solemn chapel, and trace the palace's transformation from seat of kings to prison of revolution. With your guide, you'll explore both the Conciergerie and Sainte-Chapelle as a unified complex—gaining rare insight into their layered histories, architectural achievements, and symbolic roles from the Middle Ages to the French Revolution. Return to the hotel after the tour. As evening falls, gather with your fellow travelers for dinner. Overnight in Paris. (B, D)

### Day 4: Tuesday Jun 8 2027: Guided walking tour Place des Vosges, Musée Carnavalet, Victor Hugo's Home.

After breakfast, embark on a full-day guided walking tour through the Marais, one of Paris's most historic and atmospheric neighborhoods. Known for its medieval streets, elegant hôtels particuliers, and vibrant cultural life, the Marais offers an open-air museum of centuries past. Begin your morning at the magnificent Place des Vosges—the oldest planned square in Paris and a masterpiece of 17th-century architecture. Framed by graceful red-brick façades and peaceful arcades, it captures the timeless charm of classical Paris. Continue on foot to the beautifully restored Musée Carnavalet, dedicated to the fascinating history of the city from its medieval origins to the French Revolution and beyond. Nearby, visit the Maison de Victor Hugo, where the celebrated author of *Les Misérables* once lived and wrote, his preserved apartment offering a glimpse into his creative world. After a lunch in a local restaurant, your exploration continues through the lively Jewish Quarter, especially along Rue des Rosiers, where tradition and modern Parisian life blend seamlessly. Throughout the day, your expert guide will bring to life the stories, architecture, and characters that shaped this remarkable district. Return to your hotel in the late afternoon, with the evening free to relax or enjoy the city at your own pace. Overnight in Paris. (B, L)

## **Day 5: Wednesday Jun 9 2027: Saint-Germain-des-Prés & le Musée de Cluny – A Guided Walk Through Medieval Time.**

Today, explore the heart of medieval Paris on the storied Left Bank. After breakfast, begin your day in Saint-Germain-des-Prés, one of Paris's oldest neighborhoods. Your guide will lead you through the Abbey of Saint-Germain, founded in the 6th century and once a powerful center of monastic life and early Frankish culture. As you wander the nearby lanes once lined with cloisters and chapels, you'll feel the echoes of centuries of scholarship and spiritual devotion. After lunch at leisure, continue your journey through the Middle Ages at the Musée de Cluny – Musée National du Moyen Âge, set in a Gothic mansion atop Roman baths. This unique museum brings the medieval world vividly to life through stained glass, ivory carvings, manuscripts, and religious relics. Its crown jewel is the ethereal tapestry series, The Lady and the Unicorn—an enigmatic, 15th-century masterpiece that captivates the imagination. With your expert guide, uncover the daily life, beliefs, and artistry of a distant era. Evening at leisure—perhaps linger in a historic café in the Latin Quarter. Overnight in Paris. (B)

## **Day 6: Thursday Jun 10 2027: Chartres – Masterpiece of Gothic Architecture & Organic Wines Tasting.**

Today's journey leads southwest to Chartres, a medieval gem crowned by its UNESCO-listed cathedral, one of the purest expressions of Gothic art in Europe. Built between the 12th and 13th centuries, the cathedral stuns with its soaring nave, intricate sculpted portals, and kaleidoscope of stained-glass windows that bathe the interior in soft, heavenly light. Inside, discover the Sancta Camisia, believed to be the Virgin Mary's tunic, and trace the labyrinth once followed by medieval pilgrims. Afterward, enjoy some free time in Chartres' old town, where cobbled streets and half-timbered façades invite a leisurely lunch at a local bistro on your own. In the afternoon, your journey continues to a typical French winery for a visit and tasting. Return to Paris for an evening at leisure reflecting on the day's journey. Overnight in Paris. (B)

## **Day 7: Friday Jun 11 2027: Montmartre - Sacré Coeur - Farewell Dinner.**

After breakfast, discover Montmartre, a historic hilltop district that preserves the charm of medieval Paris. Begin at the Musée de Montmartre, housed in a 17th-century residence surrounded by gardens once painted by Auguste Renoir. Continue to explore Montmartre's spiritual roots with visits to the Abbey of Montmartre site and Saint-Pierre Church, one of Paris's oldest. Then, at Clos Montmartre, the city's last working vineyard, enjoy a private tasting of wines born from centuries of tradition. Before lunch, pause at the Sacré-Cœur Basilica for breathtaking views over Paris, then enjoy lunch at leisure in one of Montmartre's cafés or bistros. This evening, celebrate your journey with a Farewell Dinner. Overnight in Paris. (B, D)

## **Day 8: Saturday Jun 12 2027: Departure.**

After a memorable journey through the medieval and artistic heart of Paris, it's time to bid "Au revoir" to the City of Light. Transfer to Charles de Gaulle Airport for your return flight back to the USA. As you make your way through the airport, take a moment to reflect on the rich history, unforgettable landmarks, and the unique charm of Paris that you've discovered during your stay. We hope this incredible journey through the medieval past has left you with lasting memories and a deeper appreciation for the city's timeless beauty. Safe travels and until we meet again! (B)

**Passenger Cancellation Policies:** No charges other than the non-refundable initial service fee/deposit are levied for individual passengers canceling up to 121 days prior to the commencement of Jet Vacations LLC services.
