Portugal's spectacular Douro River Valley and the winding river that courses through this culturally rich region have been aptly designated a UNESCO World Heritage site. With a tradition of wine production stretching back 2,000 years, Vinhateiro's port wines have been world-famous since at least the 18th century. We'll enjoy a day visit to Salamanca, Spain's "Golden City," for lunch and flamenco performance. Returning to Portugal, we'll call in Pocinho for a choice between the award-winning Côa Valley Museum or the Casa Painova for a tasting of Portuguese almonds, olives and fruit. Our visit to the village Provesende, one of the Douro's many "secrets," will offer many glimpses of ancient Portuguese small town life. Our river cruise concludes in the historic port city of Porto with visits to its many historic treasures and a private concert in São Francisco Church.
