Day-by-Day Itinerary*:

Day 1: Arrive in Kalispell, MT

Welcome to Kalispell -- the gateway to Glacier National Park! After settling in to your hotel located in Whitefish, Montana, meet your traveling companions and Orbridge Expedition Leaders for a welcome reception at your hotel.

Overnight: Grouse Mountain Lodge (R)

Day 2: Glacier National Park / Lake McDonald

Following breakfast, begin your exploration of Glacier National Park. At Lake McDonald, enjoy a scenic cruise on a historic wooden boat. Bask in the beauty of your surroundings as the captain shares the local history and folklore. Enjoy the Lake McDonald area on your own before returning to your resort in Whitefish.

Overnight: Grouse Mountain Lodge (B)

Day 3: Glacier National Park / Going-to-the-Sun Road

Continue your discovery of Glacier National Park's breathtaking scenery. Board a vintage Red Jammer bus for the journey along one of North America's most spectacular highways: Going-to-the-Sun Road. After crossing 6,664-foot-high Logan Pass, enter a wonderland of alpine scenery, where jagged mountain peaks, deep-green forests, pristine lakes, and meadows dominate the landscape. End the day on the eastern edge of the park in perfect preparation for more exploring tomorrow. Enjoy dinner at the lodge this evening.

Overnight: St. Mary Lodge & Resort (B,D)

Day 4: Glacier National Park

Spend the day in the Swiftcurrent Lake area, including a picnic lunch. There are numerous optional activities available at this location – including boat cruises, horseback rides and park ranger programs.

Overnight: St. Mary Lodge & Resort (B,L)

Day 5: Glacier National Park / Waterton Lakes National Park, Alberta

Following breakfast at the lodge, spend the morning at the Museum of the Plains Indian in Browning, Montana, before traveling north to scenic Waterton Lakes National Park. Bordering Glacier National Park, Waterton Lakes National Park is a UNESCO World Heritage Site, and is recognized as an International Peace Park.

Overnight: Prince of Wales Hotel (B,D)

Day 6: Waterton Lakes National Park

Enjoy the morning exploring the natural attractions in Waterton, including Cameron Lake, one of the jewels of the park. Opt to take a hike, rent a boat or visit the Remington Carriage Museum. This afternoon the group will relax at the famous Prince of Wales Hotel for traditional afternoon tea. Enjoy a laid-back evening in the small town of Waterton.

Overnight: Prince of Wales Hotel (B)

Day 7: Waterton Lakes National Park / Banff National Park

After departing Waterton Lakes, our first stop today is Head-Smashed-In Buffalo Jump. A UNESCO World Heritage Site, Head-Smashed-In is one of the world's oldest, largest and best-preserved buffalo jump sites. Afterward, visit the Bar U Ranch National Historic Site—dedicated to commemorating the history and importance of ranching in Canada. Enjoy a guided tour and perhaps take time for a late lunch at the Bar U Café. Continue on to Banff National Park, arriving in the late afternoon.

Overnight: Fairmont Banff Springs Hotel (B,D)

Day 8: Banff National Park

This morning, take a scenic ride on the Banff Gondola to the top of Sulphur Mountain and enjoy the spectacular views of the valley below. Additional morning sightseeing includes stops at Bow Falls and the spire-like Hoodoos. The balance of the day is at leisure or you can join an optional helicopter flightseeing trip for unsurpassed views of the Rockies.

Overnight: Fairmont Banff Springs Hotel (B)

Day 9: Banff National Park / Lake Louise

We saved the best for last: time spent at stunning Lake Louise, nestled in Banff National Park. Moderate

The majority of the program's activities will take place outdoors and a fair amount of walking on varying terrain is to be expected. Many of the parks have dirt trails, but they are usually fairly smooth for walking. Some parks have paved pathways and boardwalks. It is our expectation that guests on this program are able to get in and out of a motorcoach without assistance. If you are able to walk a mile at a moderate pace, you will be able to enjoy all of the excursions. However, there are opportunities for different abilities to enjoy the national parks. Also keep in mind that you will experience varying altitudes, to which you may not be accustomed.

This Agreement is important. It includes contractual terms and conditions and releases Orbridge, LLC from liability. It must be signed by all participants.

Responsibility. Orbridge, its shareholders, directors, officers, employees and affiliates (collectively, "Orbridge"), does not own or operate any entity which is to or does provide goods or services for your trip including, for example, ownership or control over hotels or other lodging facilities, airline, vessel, bus, van or other transportation companies, local ground operators, providers or organizers of optional excursions or equipment used thereon, food service or entertainment providers, etc., even if they use the "Orbridge" name. All such persons and entities are independent contractors. As a result, Orbridge is not liable for any negligent or willful act or failure to act of any such person or entity, or of any other third party. Without limitation, Orbridge is not responsible for any injury, loss, or damage to person or property, death, delay or inconvenience in connection with the provision of any goods or services occasioned by or resulting from, but not limited to, acts of God, acts of government, force majeure, acts of war or civil unrest, insurrection or revolt, strikes or other labor activities, criminal or terrorist activities of any kind, or the threat thereof, overbooking or downgrading of accommodations, structural or other defective conditions in hotels or other lodging facilities, mechanical or other failure of airplanes or other means of transportation or for any failure of any transportation mechanism to arrive or depart timely or safely, dangers associated with or bites from animals, pests or insects, marine life or vegetation of any sort, dangers incident to recreational activities such as scuba diving, snorkeling, paddle boarding, surfing, swimming, kayaking, sailing, canoeing, rafting, hiking, bicycling, rock climbing, etc., sanitation problems, food poisoning, lack of access to or quality of medical care, difficulty in evacuation in case of a medical or other emergency, illness, epidemics or the threat thereof or for any other cause beyond the direct control of Orbridge. In addition, I release Orbridge from its own negligence and assume all risk thereof.

Rates. Program rates are based on minimum participation levels, current fares (air, water, land), tariffs and currency values. While Orbridge does everything possible to maintain the listed program rates, they are subject to change effective immediately upon posting unless otherwise specified by Orbridge. In the case of invoicing errors, we reserve the right to re-invoice with the correct pricing.

Registration, Deposits and Final Payment. To confirm and secure your reservation, a deposit of \$850 per person per program and \$500 per person per extension, plus any non-refundable deposits are due at the time of registration payable by check, ACH, money order, wire transfer of same day U.S. funds, or major credit card. Final payment including any extension(s) and optional(s) is payable by check, ACH, money order, wire transfer of same day U.S. funds ONLY and due no later than 90 days prior to the scheduled program departure date. If your reservation is made fewer than 90 days prior to departure, the entire cost of the program, plus any extension and optional(s), is due at the time of registration by check, money order, ACH or wire transfer of same day U.S. funds ONLY. If final payment is not received by Orbridge at least 90 days prior to the scheduled program departure date, Orbridge may, at any time and with or without notice, cancel your reservation in its sole discretion with no right of refund.

Reservation Grace Period. Reservations made not fewer than 98 calendar days prior to the scheduled program departure date may be canceled at any time during the seven (7) calendar day period (the "Grace Period") immediately following the date of reservation for a full refund of all Payments received by Orbridge as of the effective date of termination. Notice of termination must be in writing, must be received by Orbridge in the Grace Period and is effective only on timely receipt of such written notice by Orbridge. For all other reservations and cancellations, the terms of the Cancellations and Refunds section below apply.

Cancellations and Refunds. All cancellations must be submitted to Orbridge in writing and will be subject to a cancellation fee ("Cancellation Fee") as follows: (a) if the cancellation notice is received by Orbridge 151 or more days prior to the scheduled departure date, the Cancellation Fee will be \$500 per person per program and \$300 per person per program for any extension; (b) if the cancellation notice is received by Orbridge between 150 and 91 days prior to the scheduled departure date the Cancellation Fee will be the full deposit per person per program including any extension; (c) if the cancellation notice is received by Orbridge 90 or fewer days prior to the scheduled departure date, the Cancellation Fee will be the full program price. In addition to and not in lieu of the foregoing, a Cancellation Fee equal to 100% of the carrier charge applies to all non-refundable airfares due to your cancellation made at any time prior to the scheduled program departure date, as applicable. Refunds, if any, of any Payments in excess of the aggregate Cancellation Fee shall be processed within 30 calendar days of our receipt of your written notice.

Travel Insurance. Orbridge strongly recommends that you purchase travel and cancellation insurance to protect your investment in the event of unexpected or unforeseen circumstances. In addition, we recommend that you consider obtaining a policy(ies) that will cover some or all of your losses associated with damage or loss of luggage or personal effects. If you do not have, but are interested in purchasing, travel and cancellation insurance please contact us immediately.

Cancelled Programs. All programs are subject to cancellation by Orbridge prior to the scheduled departure date for such reasons as, but not limited to, insufficient participation, or logistical problems that, in Orbridge's sole judgment, may impede program operations or represent conditions or events that may expose program guests and/or Orbridge to undue risk of harm, injury, damage or inconvenience. In the event of program cancellation by Orbridge, Orbridge may offer you alternative arrangements such as the option to join another tour on a different date or to a different location. If the price of your alternative booking is lower than your original booking price, Orbridge will refund the difference; or Orbridge shall refund all payments made to Orbridge at the time of cancellation should the alternative arrangement not be offered or selected.

Itineraries. Accommodations, the itinerary, and arranged excursions are subject to change or substitution at any time due to unforeseen circumstances or circumstances beyond Orbridge's control. Reasonable efforts will be made to operate programs as planned, but adjustments, substitutions and changes may occur after the final itinerary has been issued.
